Detailed information regarding engagement of advocate, enrolled with Bar Council, on full-time contract basis for Legal Support.

1- No. of Posts- 01 (one)

2- Educational Qualification & Experience:

- i. The applicant must possess a Bachelor's degree in 'Law' from a university, recognized by the Bar Council of India.
- ii. Must be enrolled as an advocate with the Bar Council of any State in India.
- iii. At least 05 years of experience of practicing before hon'ble SC or hon'ble HCs.
- iv. In addition to the forest laws, persons having good knowledge and having experience in cases related to constitutional law, Service rules, Pension & Gratuity Rules and contempt matters will be given preference.

3- Age- Maximum 55 Years (As on 01-07-2022)

4-Nature and period of appointment

The appointment of advocate is purely on contract basis and is for one year which can be extended. If the service found unsatisfactory, the contract can be terminated by Chief Conservator of Forests, Vigilance & Legal Cell at any time with one month's advance notice.

5- Honorarium payable

Honorarium of Rs. 50,000/- (Rupees fifty thousand) per month only, will be paid to the appointed advocate. Apart from this, no other allowance will be payable.

6- The following documents are required to be attached with the application

- i. Certificate of High School.
- ii. Certificate/Marksheets of Bachelor of Law.
- iii. Registration Certificate, issued by the State Bar Council.
- iv. Bar Association card/ certificate etc.
- v. Experience (minimum 05 years) certificate issued by Bar Association.

7- Procedure for appointment

- a) Interested candidate will have to apply in the format prescribed by the department, which is given on the department's website at www.forest.uk.gov.in/recruitments and [latest news](#). Application is invited

by e-mail only. Applicants have to take print out of the Application Form (annexed herewith) and fill the same with blue ball pen with all the necessary enclosures and send through e-mail with subject “APPLICATION FOR THE POST OF LEGAL ASSISTANT” at nodallegalcell.uk@gmail.com by 11.11.2022, 5 P.M.

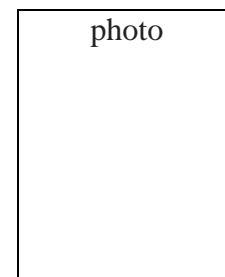
- b) On receipt of the application form, eligible candidates will be called for an interview. The selection process will be done on the basis of the recommendation of the interview board mentioned in the G.O No. 3643(1)/X-1-2017-14(06)/2000A dated 13-12-2017 issued by Uttarakhand Government, Forest and Environment Section-1. Incomplete applications will be rejected and it will not be necessary to give reasons for the same to the candidate concerned.
- c) Applicants are required to produce all their original certificates at the time of interview.
- d) The “Chief Conservator of Forests, Vigilance & Legal Cell, have the right to cancel this selection process at any stage with or without assigning any reason.

8-Responsibilities of advocate, engaged for legal assistance

- a) The appointed advocate will have to provide legal aid/advice in all matters to State Government and Forest Department.
- b) Preparation of counter affidavits on behalf of the Government/ Forest Department for Tribunals, Hon'ble Supreme Court, Hon'ble High Court, Hon'ble National Green Tribunal, by compiling other evidences, or providing the desired assistance to the state advocates who are prosecuting, record of all legal proceedings. Maintenance and other legal related work, which will be assigned to them, will have to be done with full responsibility.
- c) The person appointed on contract basis will have to render services on full time basis and he will not be able to indulge in any other type of business during the period of contract.
